<u>SCGA Representative, Course Delegate & Entertainment/9-Hole Director</u> Leo Tosh reports two Scholarship winners were chosen, there names are on the website. \$1381 left over and gave out \$2100.

Suggestion was made to re-do application to include all Ventura County schools – Pat. Pat said the scholarship fund could fall under 503C non-profit.

<u>OLMGC Webmaster</u> Mike Corr – everything is posted, and scholarship winners' information is posted.

<u>New Business</u> – Billy suggested to do the count for new Life members. A live count member was taken, and both Brad Zlomke and Mike Corr were accepted as life member.
